



## St. Barnabas School Tuition Policy

Welcome to St. Barnabas School. We are thrilled that your family has chosen to be part of our family. We ask that you take a few minutes to read and familiarize yourself with our tuition policy and procedures. Our Parish Finance Council develops an annual budget for the school and sets tuition rates based upon projected enrollment. Thus, as parents register their children, and in return for the educational services provided, they enter into a financial contract with our school. We also assign and finalize our binding faculty contracts each April based on our enrollment projections. Therefore, the obligation to pay the tuition and fees is binding.

Parental paid tuition only covers a portion of the actual price of educating your child. The balance of the cost is covered by state and federal allotments, fundraising and, most importantly, our parishioners who contribute so generously via the weekly offertory. Without their grace, prayers, and financial support, it would be impossible to keep the school operational.

### 2026/2027 Tuition Information, Plan Options, Rate & Fee Schedule

#### FACTS

St. Barnabas School contracts with FACTS Management for the software that administers all tuition plans (Preschool – 8<sup>th</sup> grade) and processes all payments, registration and field trip fees, Extended Day and Little Blazer Care billing plus other school-related expenses. By enrolling at our school, you acknowledge:

- You are REQUIRED to enroll in FACTS and select a tuition payment plan option by the due date.
- All tuition, fee payments, and other school-related expenses will be made via EFT (Electronic Funds Transfer) from a checking or savings account or by credit card (subject to a standard processing fee, currently 2.85%) directly to FACTS.
- Parents are required to maintain accurate banking information at all times so that payments process on the first attempt.
- Checks, cash, and credit card payments are not accepted at the school or parish offices.

#### FACTS Tuition Payment Plan Options

You will receive an electronic invitation to set up or renew your FACTS payment plan and this needs to be completed by the date specified in the email. Several payment plan options are available, but payments are always due on the 15<sup>th</sup> of the month (unless that date is a weekend or holiday.) Note: If you select the ten monthly payments, there is a 3% monthly surcharge added to the tuition total.

## Re-Enrollment

All current students will be automatically re-enrolled for the following academic year in January. Registration fees will be posted to FACTS accounts with a payment due date of March 15, 2026. For the 2026/2027 school year, if you choose to not re-enroll your child(ren), you must notify the Admissions Department at [admissions@barnabasohio.org](mailto:admissions@barnabasohio.org) no later than March 1, 2026. Should you choose to opt-out of re-enrollment by this deadline and then choose to opt back in at a later date, you will be subject to the \$150 Late Enrollment Fee per child.

## Delinquent Tuition Policy

In order to provide a quality Catholic education to our students at an affordable cost and to ensure the financial stability of our school, the expectation is that all tuition payments are made on time and according to the selected payment plan. For this reason, the following policy adopted by Parish Pastoral Council and Parish Finance Council will be adhered to for the management of delinquent tuition.

A \$50 late payment fee will be automatically assessed each month on payments not received by the due date. In addition, the Parish may, at its sole option and discretion, enforce any or all of the following actions:

- Students whose tuition accounts are not current on August 1 will not be permitted to begin classes for the new school year.
- Students whose tuition accounts are not current as of December 31 will not be permitted to begin classes for the second semester.
- Students whose tuition accounts are not current at re-registration will not be permitted to register for the following academic year.
- Diplomas and transcripts will be withheld and the privilege of participating in the commencement ceremony may be denied for graduating 8<sup>th</sup> graders until all tuition and other financial responsibilities are completed.
- Families selecting single or two-semester payment options who do not pay on time will automatically be converted to the monthly payment plan option.
- Instances of returned payments (NSF) will be assessed a fee of \$30 by FACTS for each occurrence
- Students whose tuition accounts are not current may be prevented from attending school and/or participating in school activities, i.e., CYO athletics, school clubs and extracurricular activities, holiday programs, etc.
- Note: Parents may request one payment date change per year. If you have an issue and know that a payment will not be able to be processed on the due date, please send an email to [mhenefeld@barnabasohio.org](mailto:mhenefeld@barnabasohio.org) a minimum of four business days prior to the due date explaining your situation and how we can help. Banking regulations prohibit us from making payment due date adjustments less than two business days out

## Tuition Refund/Withdrawal Fee Schedule

### **Cafeteria Pre-Pay Accounts**

Parents of pre-kindergarten through eighth grade students manage cafeteria funds via their family FACTS account portal. If you would like your child to purchase lunch or buy a la carte items to supplement what was brought from home, he/she will need to have funds available on their account as our cafeteria is cashless. The lunch accounts are treated like a bank debit card, in other words, they should always maintain a positive balance. Every Sunday, FACTS automatically sends an email reminder if your account is getting low or if it is in a negative balance situation. Please respond by promptly logging in to your family portal and depositing a sufficient amount to cover any delinquent balance, if appropriate, and adding funds for near term needs. Accounts with a negative balance exceeding \$40, will be subject to a weekly \$15 overdraft fee billed to the family incidentals account. Parents can also log in at any time to see what items their child has been charging.

Funds remaining at the end of the academic calendar are automatically rolled over to the following school year. If a graduating student's family has more than \$10 remaining, the balance will be refunded via check. If less than \$10, the monies will be transferred to our Lunch Account Assistance Fund to help students in need.

Our Cafeteria does not participate in the National School Lunch Program which offers free lunches to qualifying students. However, the Parish Finance Council has adopted a policy which allows families at 200% or below of the Federal Poverty Level to receive a standard "Type A" lunch (entrée, vegetable, fruit, and milk) for the reduced price of \$2.25 per meal. No application is necessary. Families that qualify will be sent additional information prior to the start of school.

### **Field Trips**

All field trips are billed through your child's FACTS account in advance of the adventure. Charges are determined based on total costs (transportation, tickets, meals, etc.) divided by the number of anticipated students attending. If you know your child will not be in school on a future day when a field trip is scheduled, (think planned vacation) please email the teacher as soon as possible so your account is not billed. **Once your account has been billed and payment received, as we have already paid the vendors in advance, there are no refunds available even if your child is home sick from school.**

## Tuition Assistance Information

St. Barnabas Catholic School's mission is to provide academic excellence and faith formation to our students. We make a concerted effort to keep our tuition affordable and competitive while offering an academically challenging curriculum with a wide variety of co-curricular activities.

We believe that a quality Catholic education should be available to all who seek it. Tuition assistance is often available for those families that qualify. Tuition assistance does not require any repayment. It is a reduction based solely on financial need.

*Types of assistance available through the State of Ohio and the Diocese of Cleveland:*

- 1. EdChoice Expansion Scholarship:** The Educational Choice Expansion Scholarship (EdChoice) Program is income based and provides K-12 students from designated public schools the opportunity to attend participating private schools. Every family is eligible to apply and receive funding no matter your annual total income. EdChoice Renewal Applications for the 2026/2027 school year will open February 1st. - 2. Jon Peterson Special Needs Scholarship:** The Jon Peterson Special Needs (JPSN) Scholarship Program provides scholarships to students who are eligible to attend kindergarten through 12th grade and have an Individualized Education Program (IEP) from their district. The amount of each scholarship will be based on the primary disability condition identified on the student's Evaluation Team Report (ETR). Students must be enrolled in the scholarship program for the entire program year to receive the full scholarship amount. Contact the school office for more information.
- 3. Diocesan Tuition Assistance (DTA)/FACTS Grant & Aid:** The Catholic Diocese of Cleveland offers Diocesan Tuition Assistance to qualifying families. Your family does not need to be registered parishioners of St. Barnabas Parish to receive this grant. FACTS Grant & Aid Assessment, an independent third-party company, conducts the financial need analysis for the Diocese and St. Barnabas School students. Everyone is eligible to apply. If you have siblings attending another school that uses FACTS, you only need to apply once. See the chart below for more information. *The application deadline for current families is March 15, 2026.* [Apply online](#)
- 4. Angel Scholarship Fund:** The Catholic Community Foundation has established The Angel Scholarship Fund to support the schools and students in the Diocese of Cleveland. Families will need to apply for Diocesan Tuition Assistance first and then fill out a separate Angel Scholarship Fund application for each child. Your family does not need to be registered parishioners of St. Barnabas Parish to receive this grant. *The application deadline for current families is April 15, 2026.* [ASF Application](#)
- 5. Fund A Dream:** Fund A Dream (FAD) is a special tuition assistance scholarship program crafted to support Catholic education. Through this initiative, donors are paired with deserving students. Each student is granted a \$2,500 scholarship, significantly reducing their annual tuition fees for one school year. St. Barnabas Finance Office will notify you if your family is eligible to apply. The application deadline for current families is March 15, 2026.
- 6. Parish Grant and Aid:** The Parish has set aside a limited amount of funds to assist PreKindergarten families with financial aid as PreK students are not eligible for any of the scholarships listed above. These awards are need based and require income verification. The maximum award is \$1,000. Information will be sent to PreK families in April.

**529 Plans:**

As a reminder, you can use up to \$10,000 annually from a 529 plan toward private school education. Please consult your tax advisor for questions.
